- 1. Use the June Budget Day at City Hall to break down the whole group into the regions that include all attending (Budget Reps and Stakeholders) and ask that group by region for their comments relating to the budget and their expectations. This group is more diverse and much larger in total (300-500) as compared to the total attendance at RBD (100-150).

- 2. After the input from the total group continue with the election of BA's. The Stakeholders can remain to see the process or leave.
- 3. Over the next 3-4 months the BA will do their Department interviews and research. They will prepare recommendations to be delivered by October 15th so we can have direct input into the department submissions to the Mayor's office by October 31st as well as the preliminary WP draft which will be given to the Mayor early in November along with preliminary comments by to the various departments.
- 4. In January the WP draft and reco's that was given to the Mayor will be discussed with the Stakeholders either through NC meetings, RBD's and/or NC Alliance meetings. [when do we do CD meetings?] At this point the BA will get true Stakeholder input as to their reco. JANUARY
- 5. Once the BA's receive the Stakeholder input on their WP reco's they can then prepare a final WP expressing the actual priorities of the Stakeholders. This final WP will be given to the City Council.
- 6. Set up a subcommittee of 2015-16 Budget Advocates by our Saturday meeting in February to work on setting up best practices for department meetings (contacts, deadlines, questions and report templates) that can be part of the Budget Day 2016-17 BA election education and help move towards the goal of department report completion by 10/31/16 with a white paper draft by mid-November.
