Also present were stakeholders Tracey Brown (Empowerment Congress West), Eric Bagdasarian (Granada Hills) and John Darnell (DONE).

2. Public Comment on non-agenda items:

- 3. Motion to approve minutes for Meeting #4 (August 3, 2020):

Carol moved to approve the minutes. Howard seconded. MOTION PASSED with 2 opposed and 5 abstentions.

4. <u>Motion to approve a budget for the Budget Advocates:</u> Extended discussion (to be addressed by the Budget & Finance Committee prior to the meeting in the future).

John DiGregorio moved to approve the Budget FY 20-21 Tab as-is. Seth seconded. MOTION PASSED. Roll Call Vote with 20 yes, 2 no and 6 abstentions.

5. Motion to approve the Financial Report: Extended discussion (see above).

John DiGregorio moved to approve the Financial Report. Howard seconded. MOTION PASSED. Roll Call Vote with 24 yes and 3 abstentions.

6. Motion to approve three papers from the Executive Committee:

Liz moved to approve the motion. Jon Liberman seconded.

Lee moved to split the question into three parts, instead of voting on three papers simultaneously. John DiGregorio seconded. There were no objections to dividing the question.

Liz moved that the Aspirations document be approved. Jon Liberman seconded. MOTION PASSED. Roll Call Vote with 7 opposed and 2 abstentions.

Liz moved to approve the paper on Reaching Out to the Neighborhood Councils Glenn seconded.

Danielle moved to amend the motion by replacing "including possible inclusion in CityWatch" with "in various types of media." Jon Liberman seconded. AMENDMENT PASSED with 1 opposition and no abstentions. Vote on motion as amended: MOTION PASSED UNANIMOUSLY.

John DiGregorio moved to use the People's Budget Los Angeles framework to guide the People's Budget Los Angeles Committee. Jon Liberman seconded. Lee moved to direct the committee to consider circumstances in which NCs do not want the budget cut, but instead want an increase. John DiGregorio seconded Lee moved to table the discussion until a committee could be formed. Brian seconded.

MOTION WITHDRAWN by Lee.

Lee moved to postpone use of the framework until the next meeting, with the allowance that the Committee on the People's Budget can take it under advisement. Brian seconded.

MOTION PASSED with 3 opposed and 1 abstention.

- 7. <u>Status Trainings</u>: Discussion. Jennifer and Barbara are to give Albert comments on the first training module by midweek and, subject to this, Albert will circulate it to all Budget Advocates by the weekend.
- 8. <u>Status committees:</u> Committee meetings should be scheduled at least 72 hours in advance.
