VII. New Business

A. Budget Hearings

- 1. <u>BAs are Tuesday afternoon</u> Budget hearings are in progress, with Budget Advocates scheduled to present at 1:00 p.m. Tuesday afternoon.
- 2. <u>Presenting are Kay Hartman, Barbara Ringuette, and David Hunter</u> Department report-backs have started populating today.

VIII. Old Business

- A. <u>Department meetings</u> Members provided status updates on reports and department meetings. Reports are needed immediately for meetings that have already occurred. This includes Controller, Neighborhood Empowerment, Police, and Zoo, as well as Street Services, when able to reschedule.

 - 3. White Paper David Hunter is working on the theme paper, and will be presenting it at tomorrow's budget hearing. Kay will make additions.

- B. <u>CF 11-1020-S3</u> Elise Ruden communicated that she has been rewriting the ordinance, based on many of Kay's requested changes.
- C. <u>Discussion with Hydee Feldstein Soto</u> As requested by Hydee Feldstein Soto, Kay marked unwanted language within the council file, designated what was desired and submitted a statement about it, written in collaboration with the Executive Committee. Changes sent to Elise and Hydee are now being incorporated.
- Discussion with Venessa Serrano Kay told Vanessa Serrano that the Budget Advocates would like to restart its relationship with the department, get on better footing, and be reinstated onto the contribution form. Vanessa agreed to do what she can. Kay will follow up once budget hearings have finished.
- E. <u>SB-411</u> This bill is in the state legislature and is proposing to amend the Brown Act allowing Neighborhood Councils to opt-in to virtual meetings. City Council must authorize the change and the author's deputy met with Neighborhood Council presidents. It is set to be passed out of committee tomorrow and into the State Judiciary, with a sunset provision of February 21, 2028, if approved.
- F. Town Hall on the City budget It has become too late to schedule a town hall this year, while avoiding Budget Day and accommodating those involved with the budget hearings. Budget Advocates will put it on the calendar for January, to schedule the event ahead of time, instead of waiting for the budget to be released.
