1. <u>Call to order:</u> The meeting was called to order by Co-chair Carol Newman at 7:01 p.m., with a full Quorum reached at 7:18 p.m.

2. <u>Roll Call</u>: See above. In addition, Budget Representatives present were: Josh Nadel (Stakeholder, Palms NC), Kay Hartman (Palms NC) and Tina Chinakarn (Palms NC). Former Budget Advocate KJ Clark was present by phone at 8:06. Visitor present was Nikita Jones-Houston (Treasurer, CANNDU NC – Region 9; Running for Budget Advocate).

3. Public Comment: None.

4. <u>Approval of minutes from Meetings #11, 12, 13, 14, 15, 16 (Carol Newman and Kay Hartman)</u>: Jon Liberman moved for the approval of minutes #11, 12, 14, 15 & 16. Barbara Ringuette seconded. Changes requested by Barbara Ringuette and Jeff Mausner were to be given to Kay Hartman after discussion. Carol Newman moved to approve

minutes as amended, Barbara Ringuette seconded. Two abstentions, no oppositions. MOTION PASSED. Kay Hartman will be in charge of editing minutes until the next Budget Day Budget Advocate election.

5. <u>Treasurer's Report (Howard Katchen)</u>: There was a discussion about items that should have been paid not always being posted to the account. Howard responded that DONE is responsible for items not always posting to the account. Barbara Ringuette moved to approve the Treasurer's Report. Jon Liberman seconded. No abstentions, two oppositions. MOTION PASSED.

- a. Motion to reimburse Budget Advocate Board member Barbara Ringuette \$166.49 for the following purchases at Staples used in producing Budget Advocates training materials: Staples Laser Bright paper \$31.98, HP 64 XL Color Ink cartridge \$46.99, HP 64 XL Black ink cartridge \$42.99, HP 64 XL Black ink cartridge discounted \$30.09, plus tax 9.50% of \$14.44. Howard Katchen moved to reimburse Barbara Ringuette for the above Staples purchases. Brian McCain seconded. One abstention, one opposition. MOTION PASSED.
- 6. Vacancies in Regions 1, 6, 7 and 9 (Carol Newman):
  - a. Report from Brian Allen on Region 9 election and Region 7 nominations: Region 9 has two candidates interested in two positions. Evelyn Valdez has resigned from CANNDU NC and is no longer a Budget Rep and therefore can no longer serve as a Budget Advocate. Region 9 candidates are Nikita Jones-Houston (Treasurer, CANNDU NC) and Alberto Farias (President, Voices NC). In Region 7, Tony Michaelis has resigned so his position should be filled. After this round of seeking candidates, the choice can be made not to fill new openings in the remainder of this term.

7. <u>Meeting with the Mayor now scheduled for March 12, 2020 at 10:15 a.m. and list of those attending (Carol Newman and Jack Humphreville):</u> The meeting is now tentatively scheduled for **March 12, at 10:15 a.m.** in the Mayor's office. Barbara Ringuette and Jack Humphreville will send an e-mail to confirm whether the meeting is on or off.

8. <u>Distribution of hard copy of White Paper to NCs (Carol Newman)</u>: Budget Advocates can get hard copies of the White Paper from Howard Katchen after the meeting and begin distributing them to the Neighborhood Councils. BAs must also start requesting funds beginning tonight with a deadline of May.

9. <u>Police Department meeting (Jon Liberman and Carol Newman)</u>: The Police Department is making extra efforts to attract women, African-Americans, and Pacific Islanders as officers. They've had difficulty attracting potential officers from these

groups. They've welcomed Budget Advocates to meet and discuss issues freely with their department, but are now asking for help funding their job fairs. A discussion took place on the issue.
