- 15. Motion on statement about Porter Ranch gas leak (Glenn, Becky, Jon, Liz) Glenn did not see Becky) Issue on storage outside city limits so city can't impose; make developers responsible for replacing low-cost housing (SB 2220 vs AB-1818) tabled
- 16. Update on Homelessness committee report/paper (Barbara) 5611 out of committee, was going to CC yesterday, looks like will pass with amendments, will allow 60 gallons if no storage within 10 (reduced to 2), sweeps again on misdemeanor theft of shopping carts, HUD not happy with criminalization under 5611, applied \$110M, received \$85M (new lawsuit ADA compliance/Willitts); homeless tents won't be allowed because of ADA/Willitts; CAO/CLA on steps necessary to put on ballot \$113M annually; emergency, treat as triage
