


Adrianne will coordinate the campaign, and Jacqueline will help. Some of CityWatch' regular writers will help with editing. We can use to introduce the Budget Advocates to a wider audience and thank the Councilmembers and Departments who do good work.

Motion by **Jon Liberman** to approve the bylaws as amended, second by **Barbara Ringuette**, and passed with 29 yeses (Ale, Allen, Amsden, Best, Burg, Edwards, Foell, Wu Freeman, Goldfarb, Gory, Handal, Hopp, Hornik, Job, Kennedy, Kidd, Kirkwood, Liberman, Massey, Menjvar, Morrison, Newman, Ramirez, Ringuette, Rodriguez, Sandoval, Seamans, Valencia, and Yvanek-Garb), 0 noes, 0 abstentions, with 1 not yet present (Velasco).

12. <u>Electeds' & Candidates' Survey update</u> – review and motion to approve proposed questions as amended (see attachment).
