- 1. <u>Call to order:</u> The meeting was called to order by Co-chair Carol Newman at 9:33 a.m., with a full quorum reached at that time.

- 3. Public Comment: None.

- 5. <u>Treasurer's report (Howard Katchen):</u> After some discussion, Jon Liberman moved for approval of the report, Barbara Ringuette seconded. One abstaining, two opposed. MOTION PASSED.
- 6. <u>Update on "meetings" of the Budget Advocates (Carol Newman):</u> Discussion on the issue. John DiGregorio agreed to set up a Zoom account and to set up Zoom for the next six meetings through June. He will also send all members a link from the Google Play Store to identify the correct app to download. Carol Newman moved to approve a payment of \$15.00 month for Zoom and to use Zoom for meetings for the foreseeable future. John DiGregorio seconded. No abstentions, no oppositions. MOTION PASSED.
