- A. <u>Update of CF 11-1020-S3</u> A discussion on the council file was slated for this week, but not scheduled. Discussion date is still undetermined.
 - 1. Ordinance suggested by Ellise Ruden
 - 2. Elise has resigned
 - a) Elise Ruden is no longer the City Attorney for BONC, but has been reassigned within the department that services DONE. A new City Attorney will be announced at Monday's BONC meeting.
