- I. <u>Welcome and Call to Order:</u> The Special Meeting was called to order by Co-Chair Jennifer Goodie at 1:09 p.m., with a full quorum in attendance.

- III. <u>Approval of minutes from meetings #18 Monday April 3rd, 2023, #19 Saturday April 15th, 2023, and #20 Monday May 1st, 2023</u> Jay Handal moved to approve the minutes from meeting #18 on Monday, April 3, 2023, meeting #19 on Saturday, April 15, 2023, and meeting #20 on Monday, May 1, 2023. Jack Humphreville seconded. MOTION PASSED, with 12 for and 2 abstentions.

VI. <u>Updates</u>

A. <u>Budget Hearings</u> – David Hunter, Barbara Ringuette, and Kay Hartman each gave a presention on an aspect of the White Paper to the Budget and Finance committee. Budget Hearings have been completed and the City Council approved the budget on Friday, along with about 200 adjustments. Hard copies of the report were provided to committee members and a link is available on the website, as well as a video of the presentation. Reports are on 23-0600, listed as Budget Advocates.

 - a) <u>Theme is Restart, Reform, Refocus...</u> The report is written, with the theme of "Restart, Reform, Refocus..." Kay and David are making final edits.
 - b) MOTION to approve white paper Item postponed to next meeting.
- B. <u>CF 11-1020-S3</u>
 - The ordinance was written by Elise and is still in committee. Several Neighborhood Councils have donated to the Budget Advocates and had their funding requests denied because the vendor was listed as "Budget Advocates," instead of "budget advocacy." The administrative code currently specifies "Budget Advocates," which should qualify the group to receive donations, provided compliance with the rules. Neighborhood Councils may use the Funding Contribution Form to donate

- 2. At the last BONC meeting, Commissioner Maggie Darett-Quiroz condemned the Budget Advocates for requesting additional funding and called for an investigation. This was in reference to Budget Advocates requesting to be re-instated on the Neighborhood Council contribution form. BONC recommended that DONE be asked for an investigative report. Kay Hartman will contact Ray Regalado, cc'ing Joy Atkinson and Len Shaffer, offering to write it.
- Man-Qin is working with Kristina Smith to bring the BTRC for the Mailroom into compliance to complete payments. The issue will be escalated to Diana, in Finance, as needed.
- C. <u>Discussion with Hydee Feldstein Soto</u> No meeting has been scheduled.
- D. <u>Discussion with Vanessa Serrano</u> No meeting has been scheduled. Kay is continuing to make contact.
- E. <u>SB-411</u>
 - 1. The bill was approved in the State Senate and has now moved on to State Assembly. It has not yet been assigned to a committee. Senator Portantino's staff is considering further amendments to make it easier for members to opt into virtual meetings. Once the bill is set for hearings, comments may be submitted by pdf within the week prior. Select "Submit comments to all" on the website to be included in the queue.
 - 2. As the bill is currently, board members joining Neighborhood Council meetings virtually may vote, but not count for quorum, unless joining for reasons of illness, child care or

elder care, according to AB2449. SB-411 intends to allow virtual attendees to count for quorum.

- 3. Budget Advocates are invited to report if their Neighborhood Councils are holding hybrid meetings and if they are choosing to deliver reports virtually. Check individual agendas to see if this is an option.
- F. <u>Town Hall on the City budget</u>
 - 1. The event could not be scheduled this year, while still avoiding Budget Day and accommodating those involved with the Budget Hearings.

Glenn Bailey moved to schedule a Town Hall on the City budget for Saturday, April 27, 2024, a week after the budget's final release date. Barbara Ringuette seconded. MOTION PASSED, with 16 for and no abstentions.
